Rail Museum Established In Philadelphia

The specially issued time-table to cover the funeral train of President Garfield from Pittsburgh to Cleveland on September 24, 1881 has been listed as Cleveland's contribution to the museum.

Arrangements are being made to obtain the old Loder automobile used by the late President Samuel R. and other Pennsylvania Railroad officials on their first trip through the Hudson River tunnel immediately after the borings had been completed in June, 1909, before tracks or signals had been placed in position.

Interesting and valuable old records, yellowed with age and musty from storage in damp cellars, time-tables and rule books, also have been received from Chicago, Decatur, Ill., Indianapolis, Terre Haute, Ind., Alliance, Ohio, New Castle, Oil City and Kittanning, Pa.

Old telegraph instruments, signal lanterns, engineers' torches, switch locks and keys, and scores of other articles that have a direct bearing on the pioneer days of American railroading are being received.

As this material is received, an accurate account is kept of each contribution so the donor's name will be placed on the display when the museum opens.

A London Italian Wins Grand Prize Of \$1772,700

London, March 27 (UP)—An Italian who came to London thirty years ago and pushed an ice cream cart through the streets became a millionaire today when Grakle won the Grand National steeplechase at Aintree.

Clayton C. Woods, 248 Carl street, Buffalo, N. Y., won the second prize. Emmilio Scala, proprietor with his brother of a coffee shop in southwest London, held Grakle's ticket in the Irish hospitals sweepstake. The first horse home won approximately \$1,772,700 for the lucky ticket holder.

Scala shared his fortune with forty relatives. He is the father of four children. His wife was ill when the family received the news that they had drawn Grakle in the Irish Sweepstake.

Scala sold a part share in the Grakle ticket to a London commission firm. He declined to say how large an interest in the ticket he sold.

Annandale's ticket, worth about \$500,905, was held by George P. Dymond of Cape Town. Dymond, holding little hope that Annandale would place, starting at odds of 100 to 1 against, offered to sell a half share in his ticket for \$12,500.

There were no takers on the eve of the race. Scala and 39 relatives, all poor, contributed three pence and four pence each (between six cents and eight cents) to buy a sweepstake ticket for the family. Scala's home was at Isola Dell'iri, Italy, before he came to London.

Prior to the race, Scala said that if he won one of the big prizes he would help his aged parents, both over 80, who are in ill health.

"I also can help my four brothers, who are all very poor, and my wife, who is ill," Scala said.

"My own desire has always been to return to school and learn some more," he added.

Gun Fight Staged After Duellists Had Agreed To Settle Their Differences

Deputy Coroner Joseph Kleindienst, and Dr. Ivor D. Fenton, the latter of whom raised the form of Raicevich, who had fallen so that his face was buried in the ashes bordering the creek channel.

Both of the injured men were immediately rushed to the police station, where preliminary medical assistance was given after which they were taken to the Locust Mountain State Hospital in the Haughney ambulance with Bill Krochin at the wheel.

At the institution further aid was rendered, but Raicevich was beyond medical assistance, passing away about nine-twenty o'clock last evening, from the wounds of the head, which caused the brains to protrude, the eye, temple, abdomen and back.

Pending an X-ray examination, it is not believed by the medics that any bullets entered Brankovich's body, the injuries of the arms, legs and head appearing to be but flesh wounds.

Following the death of the victim of the tragedy, his body was removed to the Haughney morgue in preparation for the autopsy which was performed today by Dr. Fenton.

Police Investigation Immediate data on the shooting was furnished the State Police, and Troopers McDevitt and Sweeney, of the Tamaqua Barracks were detailed to this territory to work in conjunction with the local police on the case.

Together with Chief of Police McLaughlin, the State Policemen visited the hospital, as a result of which arrangements were made for the placing of a police guard at the state institution.

Evidence collected by the police following the melee, included the two guns used by Raicevich and Brankovich, both of which were identical in construction, productions of the same firm.

While at the local station house, prior to his removal to the hospital, Brankovich, though in exceedingly weak condition, stated he had purchased his gun in town, paying thirty-two dollars for the weapon.

From utterances made by him, Brankovich allegedly threw his gun away once during the quarrel, before any injuries were inflicted, offering to resume amicable relationship, but Raicevich began firing at him from under cover, so he recovered his gun and resumed the exchange of shots.

The men used several rounds of ammunition, possibly thirty or more shots being fired. The chambers of one of the confiscated guns disclosed four cartridges fired and one that missed, while the other had four empty shells.

A number of discharged cartridges picked up at the dump by the police confirmed the report that a large number of shots had been fired.

Charles "Chesko" Chesnowski, a member of the local Indians football team, who was in the vicinity of the dump at the time of the shooting and at which time he had in his possession an air-rifle, was questioned by the police officials, but was shortly released from custody.

The pact, which was turned over to the authorities, written in the Slovak dialect, of the Serbian and Montenegrin countries, in partial translation, fixes the time of the duel, and pertains to the grievance existing between the men.

The men were doubtless ignorant of the fact that dueling is forbidden in the United States, and the fires of hate having stimulated their mentalities, chose the old world custom for the settling of their dimculties.

This unique massive will doubtless play a large part in the case when it comes to trial.

Coincidental with the translation of the message, was the fact that the man asked to render the same into English, was a cousin of the duellists.

A full translation of the note will be made today, and its contents are sure to prove of interest, as further knowledge of the origin of the calamitous happening may be contained in its lines, as well as the absolving of the winner.

No Attendants The men, contrary to fictionalized shooting affairs, were unattended by seconds, not having divulged their intentions to any of their fellow countrymen, doubtless for fear of being dissuaded.

The shooting having ended, Raicevich was left lying unconscious, partially in the creek and in the debris which forms its banks, not having the ministrations of any one until the arrival of the notified authorities.

Still in an unconscious condition, Raicevich was removed to the station house and from there to the hospital where he died, the light of knowledge never once clearing his intellect to tell his story of the tragic event.

That the range at which the shots were fired was but short, was divulged by the hospital examinations, the attendant disfigurements attesting this fact.

Crowds Gather Word of the shooting spread throughout the community with lightning rapidity and within several minutes of the actual occurrence, the road leading to the garbage disposal grounds was thronged with local residents.

Equally large was the crowd that gathered around the local station house upon the removal of the injured there for preliminary medical

treatment and from thence to the hospital.

Biographies of Principals Raicevich and Brankovich were Montenegrans, their homes being in the vicinity of Vir Bazar, in the Yugo-Slav domain.

The men had resided near Primrose colliery, since their importation here several years ago by the Portland Contracting Company, a Pottsville firm which had rock work contracts in mines in this section.

The completion of these contracts found the men desiring to remain in the region and they secured jobs at local collieries. For the past several months the men had been employed as miners inside at the Morea colliery.

An ill-feeling gradually grew between the men, quarrels ensuing. Their friends urged the pair to separate, and as a result, Brankovich is said to have been contemplating a visit to his family in Yugo-Slavia. Sunday the men engaged in an argument which resulted in Brankovich remaining home from work for two days during the current week.

While two other men, who also lived in the same building, were visiting town, the men carried out their plan of extermination.

The dead man, who was forty-two years of age, was married in 1918, his wife, two sons and two daughters surviving him in Montenegro.

Brankovich, the older of the two men, who is forty-eight years of age, is also married, a wife and two sons residing in the vicinity of the relatives of Raicevich. His marriage occurred in 1920.

During their residence in this section the men had affiliated themselves with the Orthodox church of the Holy Trinity, at McAdoo, where interment will be made Sunday.

Both men were also members of the Society of the Holy Trinity, a church order.

The remains of Raicevich will be removed to the home of Stephen Vugovich, in Hazleton, from where the funeral will be held Sunday afternoon.

Both men were of unassuming disposition, according to their friends, who express great surprise at the outcome of the quarrel.

Autopsy Held Today Dr. Ivor D. Fenton, the physician who rendered ministrations to both men last evening, performed an autopsy on the dead man this morning.

His findings disclosed that the man was struck by three bullets, the wounds caused by any one of which would have resulted in death. One bullet entered the right hip, entering the abdomen and perforating the intestine in four places, finally lodging in the pelvis.

Four wounds in the head were caused by the two other shots, one of which entered the right side of the face between the ear and eye, while the second punctured the left eye and lodged in the brain.

An examination of the body failed to reveal any bruises which might have resulted in previous hand combats, the only marks being two slight abrasions of the back.

Boy Is Killed Mining Coal At Pottsville

Pottsville, Pa., March 27 (UP)—Anthracite mining today claimed its youngest victim since adoption of child labor laws with the death of Chris Minchoff, 13, killed under a fall of top rock in the tunnel of an anthracite outcrop here.

The boy was working in an abandoned tunnel mining coal for the use of the family when the fall occurred, according to the police.

A rescue squad of five men worked in the narrow tunnel for hours before reaching the body just before midnight.

Three other members of the family were trapped in the tunnel, on the property of the Lehigh Valley Coal Company at Yorkville, a suburb.

The father, Frank Minchoff, directing the mining operations, and two other sons, Carl, 12, and Frank, 15, were released from the slide soon after the top crashed down on them.

They joined the search for the missing boy, a search that ended with finding his body.

The father was employed in the daytime as a miner by the Sherman Coal Company here. In common with scores of others in the lower anthracite section, police said, he sought to add to his income by mining in the unused tunnel and used his sons as his helpers. The practice is termed "coal bootlegging."

Investigators today learned that Minchoff had failed to place timbers in the tunnel to support the sides and the roof as the coal was removed.
